Mobile Food Establishment (“Food Truck”) Permit Application

1. All Mobile Food Establishments (commonly referred to as “Food Trucks”) permitted to operate in the City of Cameron, Texas must meet the requirements of the Texas Department of State Health Services (TDSHS) for Mobile Food Establishments. Applicants must have a current Mobile Food Establishment license from TDSHS including passing the TDSHS inspection for public sanitation and retail food safety. A copy of your TDSHS Application, Inspection report and License/Permit should be attached to this application.
2. Only one unit is allowed per application.
3. A non-refundable application fee to operate in the City of Cameron in the amount of \$25 is due with this application. Applications can be made at any time during the year (January-December), however this fee is not pro-rated.
