1. PLEASE NOTE: THE JUDGE CANNOT DISCUSS THE MERITS OF THE CASE BEFORE COURT.
2. If you FAIL TO ENTER A PLEA to the charge BY THE DUE DATE ON THE CITATION, an additional charge may be filed against you and a WARRANT issued for your arrest..
3. If you wish to enter a plea of GUILTY OR NOLO CONTENDERE and pay your fine, Check #1 or #2 Refer to the fine schedule. Remit your payment to the court.(These fines apply only to cases handled prior to trial or judgement being entered.)
4. If you wish to enter a plea of NOT GUILTY and desire a trial, advise the court by checking #4 or #5 on the Plea Form below, on or before the due date on the citation. You will be notified by the court when your court date has been set.
5. You **may** be able to **request** a Driving Safety Course. **ALL paper work must be turned in by the Due date on the citation or you will lose the right to the Driver Safety Course.**
6. You may also request Deferred Disposition by pleading Guilty or Nolo Contendere (check #3). **\$334.00 is the cost and is due by due date on citation. - Class C only**

Plea Must be Made in Writing or in Person On or Before Your Due Date

Juveniles 16 & under must have a parent contact the court to set an appearance date with the Judge.

A telephone call does not constitute an appearance!

- 1 DO NOT COMPLETE DSC COURSE UNTIL THE COURT GRANTS YOU PERMISSION**
- Complete both sides of this form - Have signature on affidavit Notarized
- Must provide copy of valid Texas Driver's License with current address
- Must provide copy of current liability insurance
- Enter a plea of No Contest (Nolo Contendere) or Guilty **CHECK LINE 1 OR 2**
- Send CASHIER'S CHECK or MONEY ORDER in the amount of **\$144.00 ONLY ***
- Above named items must be postmarked **ON** or **BEFORE** your due date
- You are NOT ELIGIBLE to take a driving safety course if you were traveling at a rate of speed that is 25mph over the posted speed limit or have taken DSC in the last 12 months.**
- CDL License holders are NOT ELIGIBLE for Driving Safety Course**
